NSDL e-Governance Infrastructure Limited believes in creating a positive impact over the society to the extent feasible and is strongly committed towards Corporate Social Responsibility (CSR) and has been making contributions to various socially useful projects in accordance with its CSR Policy. In consonance with the broad provisions outlined in the Companies Act, 2013, the Company has spent Rs. 268.95 lakhs during FY 2017-18 on CSR activities / projects as defined in schedule VII of the Companies Act, 2013. During the year under review, the Company, while continuing to support its ongoing projects, has associated itself with few new projects and also intends to expand its CSR initiatives in a systematic manner to create meaningful contribution in the development of the under- privileged and weaker sections of society. The Company envisages valuable CSR spend in more structured manner in future for which it has initiated a long term project in the field of education. During FY'16 an amount of Rs.58 lakhs was earmarked for contribution to this project. As this project was in the initial stage and had gone operational only in last quarter of FY'17, partial disbursement of Rs.20 Lakhs was done for the first phase of the said project. Thereafter the Company had further earmarked Rs.20.5 Lakhs during FY'17 to this project. Thus an amount of about Rs.58.5 lakhs (Rs.38 lakhs balance from the initial allocation of Rs.58 Lakhs for FY'16 & Rs.20.5 Lakhs earmarked from FY'17) was carried forward to be spent in FY'18 out of which Rs.34.20 lakhs has been disbursed thus leaving a balance of Rs.24.30 Lakh out of the earmarked CSR funds for the said project. For FY'18, further amount of Rs.58 Lakhs is earmarked by the company as contribution towards this project thus leaving a unspent balance of Rs.11.88 Lakhs out of the total CSR liability of Rs.338.82 for FY'18. The Board has decided to carry forward this balance amount of Rs.11.88 Lakhs to FY 2018-19.

In view of this, balance amount of about 94.18 lakhs (Rs.82.3 lakhs earmarked for the abovementioned project in the education field plus Rs.11.88 unallocated balance amount of the total CSR liability of this year) is being carried forward to be spent in FY 2018-19.
